A. July 23, 2025 Board of Trustees Regular Meeting Minutes

Vice Chair Trudy Bartley moved to approve the July 23, 2025 Board of Trustees regular meeting minutes, seconded by Trustee Amy Taylor. Motion carried.

4. Comments or Statements from the Audience

Belinda Spinosi said she witnessed a wheelchair not able to board bus; the ramp didn't work. Ms. Spinosi asked that the Accessible Transportation Advisory Committee report to the COTA Board of Trustees and for the committee to meet more frequently. She requested a meeting with the president to discuss how to make COTA completely accessible and submitted documents for the record.

5. President's Report

COTA President/CEO Monica Téllez-Fowler highlighted items in the LinkUS September

Progress Report, including: ridership is up 10 percent year of year; COTA staff engaged the community about the development of Line 30; approximately 5,000 stakeholders have been engaged in the past four months about bus rapid transit design and COTA is working with stakeholders through construction and operationalization; and 37 projects that will build infrastructure such as sidewalks, bikeways and trails funded by LinkUS will begin January 2026. President Téllez-Fowler introduced COTA Chief LinkUS Program Officer Dorinda McCombs and COTA Chief Financial Officer Earl Jackson. She also noted that with school back in session, COTA's Educational Pass Program continues to grow, and 26 COTA employees are enrolled at Franklin University or DeVry under a professional development program offered through COTA. President Téllez-Fowler said staff are planning for 2026 and beyond, and the final operating and capital budgets will be submitted to the Board for its approval at its December meeting. She also thanked Trustee Doug McCollough for joining the Board, noting his technology background will assist COTA in innovations needed to effectively operationalize bus rapid transit.

6. Governance Committee Report - Sean Mentel, Chair

Governance Committee Chair Sean Mentel reported that this committee met on September 18, 2025, where they heard committee reports, four resolutions for the Innovation and Technology Division were presented for the consent agenda, the committee reviewed the other resolutions that are on today's consent agenda, and a resolution—also for the consent agenda—for the election of officers was presented, naming COTA's newly hired Chief Financial Officer Earl Jackson as Secretary Treasurer.

- 7. Strategic and Operational Planning Committee Report Trudy Bartley, Chair
 - Strategic and Operational Planning Committee Chair Trudy Bartley reported that this committee met on September 9, 2025, where they heard presentations providing the annual Information Technology/Innovation update; a LinkUS update, and the COTA//Plus Service Provider Plan. One resolution, recommended for the consent agenda, was presented.
- **8.** External Stakeholder Relations Committee Report Erika Clark Jones, Chair External Stakeholder Relations Committee Chair Erika Clark Jones reported that this committee met on September 11, 2025, where they heard a progress report on the no fare feasibility study; a presentation on the COTA//Plus Service Provider Plan, and an update on LinkUS communications and engagement work.
- 9. Performance Monitoring/Audit Committee Report Marc Reitter, Chair

Performance Audit/Monitoring Committee Chair Marc Reitter reported that this committee met on September 11, 2025, where Doug McCollough, appointed by the City of Columbus, was sworn in as trustee; the committee received a financial

update through July 2025, an operational performance update, and a Performance Incentive Compensation mid-year update. Also, the committee heard from the Office of the State Auditor that the three reports that office completed were issued with unmodified opinions. The committee heard 39 resolutions that were recommended for the consent agenda; Chair Reitter noted 31 of these resolutions were the first transit supportive infrastructure grant agreements.
