1. CALL TO ORDER

Chair Sloat called the March 16, 2022 Performance Monitoring/Audit Committee meeting to order at 3:00 PM.

3. APPROVAL OF PERFORMANCE MONITORING/AUDIT COMMITTEE MINUTES

Trustee Walker moved to approve the December 8, 2021 meeting minutes; Trustee Colley seconded. Motion carried.

4. UNAUDITED FINANCIALS

CFO Angel Mumma provided a brief financial update through January 2022 which included the following details:

RIDERSHIP

February 2022 ridership totaled 1,318,922 boardings, a 7.5% or 91,738 increase in boardings from year-to-date 2021. Current ridership totals reflect a 2.5% or 34,048 decrease from the ridership anticipated in 2022.

OPERATING FUND BALANCE

COTA's General Operating Fund reflected a cash balance of \$319.4 million as of January 31, 2022. As COTA moves from an accrual basis method of accounting to a cash basis method, the beginning balance as of January 1, 2022, may change slightly, thereby changing our fund balance













as adjustments are made. The fund balance will adjust each month as revenues are received and obligations are paid.

SALES TAX

Sales tax revenue continues to perform strong, 2021 receipts reflected a 15.0% or \$19.9 million increase over 2020, with the same pattern continuing in early 2022. Receipts through January totaled \$13.6 million, a 13.4% or \$1.6 million increase over the 2022 budget and a 19% or nearly \$2.2 million increase over 2021 receipts through the same period.

OPERATING REVENUES

Operating revenue generated in February 2022 by passenger fares totaled approximately \$585,000. This amount is approximately \$110,000 more than received in January 2022, given the increase in ridership.

NET OPERATING POSITION

As a result of operating expenditures exceeding operating revenue, COTA's net operating position reflected a decrease of approximately \$888,000 for the year.

INVESTMENT SUMMARY

COTA's overall cash balance as of January 31, 2022 is \$322,813,074. Detailed information regarding COTA's investments is provided in the meeting materials.

Trustee Walker asked if COTA had experienced any impacts from current inflation and supply chain issues. Angel Mumma responded that COTA had been fortunate not to have seen any major shipping delays or price increases.
